Prereminder 3 days before due date

Extended Use Charge notice at 7 days overdue

Final Notice/ Bill at 33 days later

Maximum Late Fee: \$5.00 for new DVDs and videogames, \$5.00 - \$25.00 for Children’s Cool Stuff, and \$2.00 all other materials
